- 3 (2) CLERICAL AMENDMENT.—The table of sec-
- 4 tions at the beginning of such subchapter is amend-
- 5 ed by inserting after the item related to section
- 6 1722B the following new item:

"1722C. Copayments: prohibition on collection of copayments for first three mental health care outpatient visits of veterans.".

- 7 (b) APPLICABILITY.—The amendments made by sub-
- 8 section (a) shall apply with respect to mental health care
- 9 outpatient visits occurring on or after the date that is 180
- 10 days after the date of the enactment of this Act.
